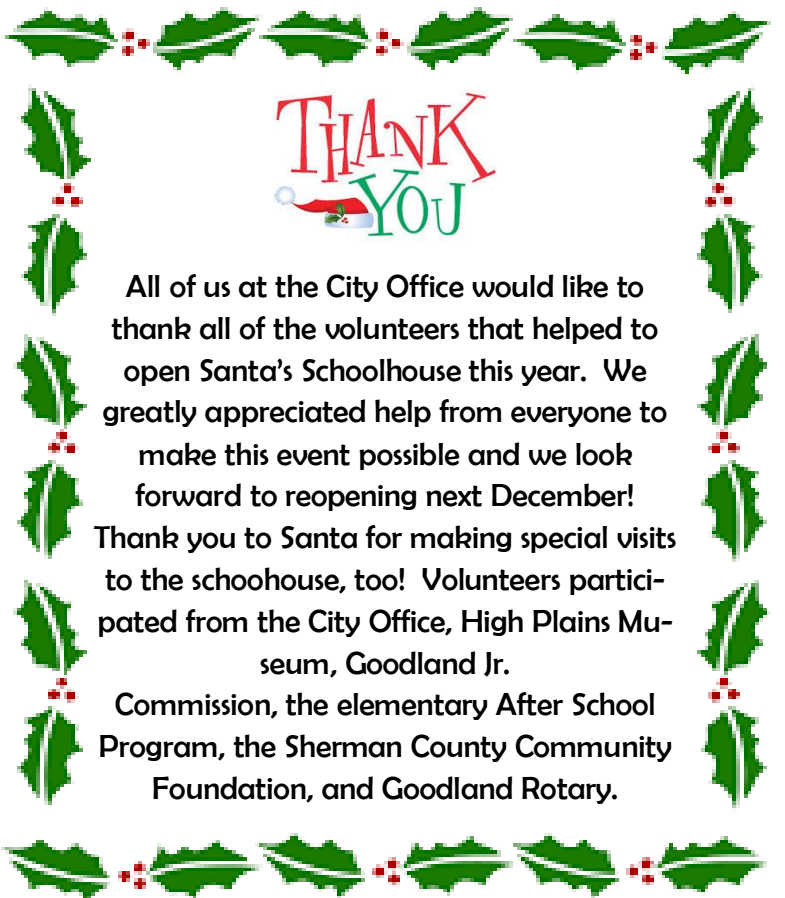

Message from the Manager...

Happy New Year 2019

From all of us at the City of Goodland, I would like to wish the Goodland community a Happy New Year. As we enter 2019, I think it is important to reflect upon the successes of 2018 and to convey how we have been responsible stewards of your tax dollars.

The City has always focused on infrastructure improvements in our community and 2018 was no exception. This past year, construction began on a \$2.3 million street rehabilitation and pavement project addressing numerous streets across Goodland. At the end of the year, pavement and/or curb and gutter work has been completed on 16th Street, Industrial Park Road, Cherry Street from 17th to 12th, and 15th Street from Cherry to Caldwell. This project will be completed in Spring of 2019 with work on 15th Street from Main to Caldwell, Eastridge from 10th to Eustis, Eustis from 8th to 4th, 10th Street from Main to Broadway, Center from 17th to 16th, Sherman from 17th to 14th, 4th Street from Grand to Sherman, and 25th Street from Commerce to the ballfields.

The Electric Department was able to complete its first phase of replacing street lights on Highway 24 east of the Highway 27 intersection with new LED lights. These lights allow for increased visibility and lower operational cost. In addition, we ran all underground conduit for this project, so no more overhead power lines!

In 2018, the City was able to acquire and remodel property at 524 E. Highway 24 which has become the new Goodland Welcome Center. Its location immediately in front of our biggest tourist attraction – the Van Gogh painting – has allowed us to interact with a record number of visitors to our community, enabling us to help direct them to local businesses and attractions.

The services our firefighters and police officers provide become more demanding each year as calls for service seem to continue to increase annually. I would urge you to thank our first responders every opportunity you can as they put themselves in harms way to afford us the security and protection we all enjoy.

The City continues to pursue unfit and hazardous structures in the community. While there are always more unfit structures to be addressed than funding allows in a given year, we were able to address six properties in 2018 which had hazardous and blighted conditions.

This December we were able to organize the first “Santa’s Schoolhouse” in Goodland. Utilizing the one-room school house next to the High Plains Museum, we were able to give families the opportunity to enjoy an early 1900’s Christmas, complete with Santa, his sleigh, and historical decorations and goodie bags for the kids. This was the “trial run” of an event we hope to grow and improve upon for years to come.

City administration is always looking for grant opportunities to help fund projects and take the burden off our taxpayers. In 2018, we were able to secure grant funding for another block of Main Street brick street improvements from the Kansas Department of Transportation (\$300,000), trail funding from the Dane G. Hansen Foundation (\$250,000), playground equipment from the Dane G. Hansen Foundation (\$15,000), a replacement Police K-9 from the Dane G. Hansen Foundation (\$5,000), funding for Run for the Wall from the Sherman Community Foundation (\$5,000), a replacement Police K-9 from the Sherman Community Foundation (\$5,000), playground equipment from the Sherman Community Foundation (\$5,000), the Santa’s Schoolhouse project from the Sherman Community Foundation (\$5,000), and improvements to the flower bed on the north side of Gulick Park from the Sherman County Community Foundation (\$3,300). There are dozens of other projects the City has accomplished in 2018, but hey, they only give me a page! We are able to achieve so much here thanks to our excellent staff. The City is, after all, an organization made up of people; many of whom have committed their lives to public service. I would also like to thank our City Commission for doing the difficult and often thankless work that elected officials are tasked with doing.

Again, Happy New Year from the City of Goodland – let’s make the year 2019 even better than the last!
