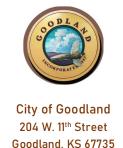

A. Temp Liquor Permit - Sherman County Community Foundation

Sherman County Community Foundation would like to host "Leave a Legacy Event" at the High Plains Museum on June 29, 2023. They would serve alcoholic beverages (not selling) to citizens attending event.

RECOMMENDED MOTION: I move to approve the temporary event liquor license for Sherman County Community Foundation during the Leave a Legacy Event at the High Plains Museum on June 29, 2023."

B. Water Department radio proposal

Water dept. received notice of Motorola radio equipment that connects various portions of our water system need to be replaced and no longer can be maintained. Equipment was installed between 2001 and 2005 and has exceeded the expected life span by at least double. After presenting the item for discussion in March 2023, staff has now received a revised quote from Timberline. Staff recommends approval of the revised quote. *RECOMMENDED MOTION: I move to approve the quote from Timberline Electric & Control Corporation for 130,030.00."*

C. Engineering contract – Industrial Park project for BASE grant implementation
The City was awarded a BASE (Building a Stronger Economy) Grant for extension of water
and sewer utilities as well as a street extension in the Goodland Industrial Park. After
getting approval from the Kansas Department of Commerce that a RFQ for engineering
services did not need to be completed, staff requested a contract to develop plans &
specifications for these 3 projects as well as construction engineering inspection &
construction observation services for the same projects. EBH Engineer has submitted a

D. IFB - 2023-07 Demolition Award Bid

contract proposal for Commission approval.

See CCCF. This is our solicitation for the revised project for the Demolition and Removal of Structures at 1523 Colorado Ave. Legal description of SHARP'S ADDN TO GOODLAND, BLOCK 4, Lot 10 - 11. This would remove the two trailers on the property. A bid was received and staff recommends award to the low bidder from B&K Pumping for \$ 4850. *RECOMMENDED MOTION: "I move to approve the bid from B&K Pumping for \$4,850."*

E. Contract Mowing and Abatement Services

Previously, an invitation for bid for mowing abatement when we have to enforce on properties with grass and weed violations was published with a deadline of April 12, 2023. There were no bids received. Staff then contacted different operators directly in order to receive the enclosed quote. The one quote was received from Damon Rickard, who will perform the service for \$32 an hour. Staff recommends to approve the quote from Mr. Rickard.

Vice-Mayor J. J. Howard called the meeting to order with Commissioner Jason Showalter, Commissioner Ann Myers and Commissioner Brook Redlin responding to roll call. Mayor Aaron Thompson was reported absent.

 ON A MOTION by Commissioner Showalter to approve Consent Agenda seconded by Commissioner Redlin. MOTION carried on a VOTE of 4-0.

PRESENTATIONS & PROCLAMATIONS

A. National Police Week Proclamation – Vice-Mayor Howard proclaimed the week of May 14th through 20th as National Police Week in the City of Goodland. Vice-Mayor Howard thanked all police officers for their service in protecting our community. Commissioner Showalter stated, I appreciate all of you and what you do, especially in your work with the college. It is important to thank your families for their support in what you do.

ORDINANCES & RESOLUTIONS

- A. Resolution 1613: Pool Fees Kent stated, staff has reviewed fees and realize the pool is not a money maker for the City, but an amenity. Resolution 1613 increases lessons \$5.00, limits family pass to four members, then \$15.00 for each additional family member, and added a ten day punch pass option for admission. Commissioner Myers asked, what is individual admission? Kent stated, anyone over 4 years of age \$4.00. Vice-Mayor Howard stated, anyone 4 and under is free. Commissioner Showalter asked, when someone purchases a family pass, only those four individuals listed on the pass are admitted to pool. Kent stated, yes additional individuals on pass are \$15.00 each. Our numbers from last year were 30 individual passes, 99 family passes, 128 swim lessons and daily admission averaged 56. Vice-Mayor Howard stated, this is good for the community and we know it will not make money. ON A MOTION by Commissioner Showalter to approve Resolution 1613: Pool Fees seconded by Commissioner Redlin. MOTION carried on a VOTE of 4-0.
- **B.** Resolution 1614: Matching Funds for BASE 2.0 Grant Kent stated, the City was notified of grant award the end of April to extend road and utilities in Industrial Park. Grant is 75/25 split and State requires proof of matching funds which is outlined in resolution. The funds outlined can change, but we need to have documentation of local funding prior to disbursement. If we are able to have other matching funds, we can adjust in future. I have inquired with innovation center for additional funding, if possible. Grant project must be complete in 2025. Vice-Mayor Howard stated, having infrastructure in place will help in attracting business. Commissioner Showalter stated, I am excited to be on the commission to move Industrial Park forward; it has been on the table for many years. **ON A MOTION by** Commissioner Redlin to approve Resolution 1614: Matching Funds for BASE 2.0 Grant seconded by Commissioner Myers. **MOTION carried on a VOTE of 4-0.**

FORMAL ACTIONS

- A. IFB 2023-05: Wheel Loader Bids Kenton stated, we received seven bids for loader. There have been concerns as to why we selected new over used. In the past, the loaders last the City more than thirty years, which is a good life span and I would not recommend purchasing this equipment used. Purchasing new we get 20% discount with government pricing. I spoke with CAT Salesman, they have a 2017 loader with 4,000 hours for \$185,000 and a 2021 with 1,100 hours which would price as new loader today. Those prices do not include a JRB coupler, so we would have to purchase separately. Vice-Mayor Howard stated, there is also less warranty buying used. Kenton stated, we posted bid request on web site and Bidnet.com. Bids received are:
 - Kan Equip model JCB427Z with base price \$194,194; fork alternate \$7,200; no scale alternate
 - Murphy Tractor model 2023JD524P with base price \$231,776.54; fork alternative is \$8,340; scale alternate is \$6,814
 - MTC model 2023XCMG with base price \$173,500; fork alternate \$6,500; scale included
 - Foley Equip model 926M for base price \$213,853.12; fork alternate \$8,240; scale alternate \$10,890
 - VLP-KC model Case621G with base price \$197,615; fork alternate \$8,281.50; scale alternate \$5,570
 - Berry Tractor model Komatsu WA 320-8 with base price \$223,520.81; fork and scale alternates not quoted
 - Central Power Systems and Services, LLC model Doosan DL-220 with base price \$162,602; fork alternate \$7,800; scale alternate \$12,500 (installed and training)

The forks and scale were requested on specifications as a options. I recommend Doosan DL-220 from Central Power Systems and Services, LLC with a set of forks for total of \$170,402. We are not recommending scale, as it is not a necessity. Vice-Mayor Howard asked, where are they located and what kind of warranty do we get? Kenton stated, Colby and Garden City. Warranty is three year, 5,000 hours full machine. They plan to deliver loader 11/230/23. Vice-Mayor Howard asked, do all bids offer same warranty? Kenton stated, no. Vice-Mayor Howard asked, did we have a loader go down recently? Kenton stated, the New Holland broke down during cleanup but it can be fixed. This loader replaces our 1990 John Deere. Commissioner Showalter asked, what are plans for old loader? Kenton stated, put on auction which will put money back into reserve because eventually we will have to upgrade other loader. The city has purchased used equipment before but with purchasing policy it would be difficult to compare apples to apples. The loader is used by multiple departments all the time. It gets most use during snow removal. Kent stated, in addition, the 33 year old loader requires some maintenance now. Kenton stated, it needs tires which were quoted at \$8,000. ON A MOTION by Commissioner Showalter to approve purchase of 2023 Wheel Loader with a set of forks from Central Power Systems & Services, LLC for Doosan DL-220 Wheel Loader in the total amount of \$170,402 seconded by Commissioner Myers. MOTION carried on a VOTE of 4-0.

B. Chip Rock Delivery Award - Kenton stated, we received one bid from Heartland Carriers. It is a good bid; less than our price last year. We will need 800 tons of rock this year. Costs for chip sealing this year are B&H Paving went from \$.46 to \$.49 this year, ergon oil from \$2.95 to \$2.91 this year. Cobitco will fog seal with ergon oil from \$3.29 to \$3.41 this year and rock increased \$5.00 a ton, not including delivery which decreased. I recommend bid from Heartland Carriers for total price of \$10,240 delivered to Goodland. **ON A MOTION by** Commissioner Showalter to award the bid for chip rock delivery to Heartland Carriers at \$12.80 per ton for total price of \$10,240 seconded by Commissioner Redlin. **MOTION carried on a VOTE of 4-0.**

DISCUSSION

A. Deadline for City Commissioner Election Application – Kent stated, general reminder filing deadline for next city commission election is June 1st at noon. Election includes seats held by Mayor Thompson, Vice-Mayor Howard and Commissioner Myers. There is information in packet stating anyone seeking office must be a qualified voter and file application with County Clerk.

A. City Manager - 1. Manager memo is in packet. 2. April financial report and the police monthly activity report are in packet. 3. The auditors are doing field work this week for year ended 12/31/2022. Report will be presented in couple months. 4. 1523 Colorado Avenue is down to one trailer and to be fair, we are collecting another set of bid information with revised scope for next This demolition will require capping three different sewer lines on property. 5. We discussed the sale of real property owned by the City. On commercial property it is better to have it sold at auction to receive more accurate response as far as pricing for said property. We need direction from commission on how to proceed. With an auction you can set a minimum price for property. Commissioner Showalter stated, I am nervous to offer a piece of property on one of our exits. If it is not a use that is attractive for City, it may hurt us. May want to hold off and use property if a business wants to come to town. Commissioner Myers stated, that is a good point, we do not need a parking lot. Vice-Mayor Howard stated, we can have requirements such as a minimum time to build on property. Commissioner Showalter stated, I feel we should work with SCCD on use of property. Kent stated, right now we can be very limited on use of property because we own it. We lose control if we sell. Jake stated, if you put reversion language in deed, that is your private business sale. If it is an auction, you lose control of any restrictions on property but it has to meet zoning regulations. Vice-Mayor Howard stated, talk with SCCD to see if they have any interest before we sell property. Kent stated, there is no urgency.

B. City Commissioners

Vice-Mayor Howard -1. Thank all city employees, never get enough thanks for what they do. They do a lot behind the scenes.

Commissioner Showalter – 1. Thank you to city crews in clean up. I drove around and looked at piles, for the most part, people were gracious; however, there were some that I felt took advantage of program. As we move forward we need to look at rules. I appreciate what crews did. 2. Frank have you done any research on flock cameras, what are your thoughts. Would you be interested in talking to us about them? Frank stated, I would entertain that as I have looked into them.

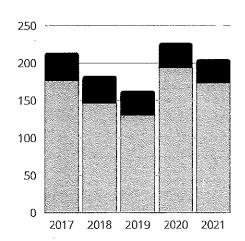

REQUEST OR ISSUE: Water dept. received notice of Motorola radio equipment that connects various portions of our water system need to be replaced and no longer can be maintained. This will upgrade the Moscads to Xetawave.

II. RECOMMENDED ACTION / NEXT STEP:

Staff will review portions to be completed in 2023 and portions that will need to be budgeted in subsequent budgets.

III. FISCAL IMPACTS:

Item will be purchased out of municipal equipment reserve fund (MERF) for well control updates in the amount of 88,290 for 2023 and borrowing funds from other projects previously approved in MERF for the water utility where funds are available. The Commission will need to approve 2024 water transfers during the budget process to payback these water projects and staff will need to consider future transfers to keep the system updated.

IV. <u>BACKGROUND INFORMATION:</u>

There is a licensed UHF radio system that connects several parts of the municipal water system. Motorola Moscads were installed between 2001 and 2005. They have exceed their expected lifespan (by a significant time period). The vendor has notified their customers previously (although not the City of Goodland) that they would no longer provide support or have parts available to maintain these systems. Staff will provide additional information at the Commission meeting.

Issue was presented at the March 6, 2023 Commission meeting. At that time, staff stated we would start talking to them about how to do the project in phases to ensure it will work and that the commission would be updated. At that time the consensus of the Commission was to work with Timberline for a number of reasons and to move ahead with the project in phases to keep system operating.

Staff has received a revised quote after discussions with Timberline. Item #6 has been eliminated due to the work completed by Josh Jordan, IT Director, on a software ready

virtual server on the Goodland system. Due to delivery times (equipment would arrive in the fall), Timberline has offered to work with the City to meet the City's needs for available resources to pay for the project. Project would be completed in its entirety by the end of 2023 utilizing funds beyond the \$88,290 from other water projects.

III. <u>BACKGROUND INFORMATION:</u> The City was awarded a BASE (Building a Stronger Economy) Grant for extension of water and sewer utilities as well as a street extension in the Goodland Industrial Park. After getting approval from the Kansas Department of Commerce that a RFQ for engineering services did not need to be completed, staff requested a contract to develop plans & specifications for these 3 projects as well as construction engineering inspection & construction observation services for the same projects. EBH Engineer has submitted a contract proposal for Commission approval.

Since the grant award was for 90% of the original application, EBH has reduced the contract amount from the amount that was included in the grant application. In addition, Andrew Brunner stated that the contract was revised due to review of the project parameters. The original estimated amount for engineering costs included the following: \$30,000 for water/sewer project design, \$39,000 for water/sewer project inspection and observation, \$88,000 for street engineering design, \$148,000 for street engineering project inspection and observation.

This *CONTRACT* is made and executed in duplicate this _____day of______, 2023 by and between the CITY OF GOODLAND, KANSAS, hereinafter called *OWNER*, party of the first part; and EVANS, BIERLY, HUTCHISON & ASSOCIATES, P.A., Consulting Engineers, Goodland, Kansas, hereinafter called *ENGINEER*, party of the second part.

As used hereinafter, the **PROJECT** shall consist of engineering services for the construction of the following, or any part thereof:

• Goodland Industrial Park; water extension, sewer extension, and street extension.

Witnesseth: That in consideration of the mutual covenants contained herein, **OWNER** hereby agrees to employ **ENGINEER** to perform the Engineering Services hereinafter outlined, and to make payment for these services as set forth below:

SECTION 1 - ENGINEERING SERVICES

1.1 SURVEY SERVICES

- 1.1.1 Field Design Surveys for the *PROJECT*.
- 1.1.2 Conduct Property and Site Surveys for use in *PROJECT* design of the improvements.

1.2 ENGINEERING DESIGN

- 1.2.1 Attend public and city meetings as required.
- 1.2.2 Prepare necessary working Drawings and Specifications.
- 1.2.3 Review Preliminary plans with *OWNER*.
- 1.2.4 Prepare final working Drawings, Specifications, an opinion of probable cost and submit to *OWNER* for approval.
- 1.2.5 Prepare and submit the documents for obtaining the Stormwater Permit Notice of Intent (NOI) prior to beginning construction on the **PROJECT**.
- 1.2.6 Prepare and submit the documents for obtaining the KDHE Sewer Extension Permit prior to beginning construction on the *PROJECT*.
- 1.2.7 Prepare and submit the documents for obtaining the KDHE Public Water Supply Permit Application prior to beginning construction on the *PROJECT*.
- 1.2.8 Obtain other required state approvals of the plans and specifications prior to construction.
- 1.2.9 Assist *OWNER* in advertising construction improvements for bids.
- 1.2.10 Provide bidding documents to the Bidders, attend bid opening and prepare bid tabulation.
- 1.2.11 Prepare and provide recommendations and assist *OWNER* in award of construction contract.

1.3 CONSTRUCTION ENGINEERING AND CONSTRUCTION OBSERVATION

- 1.3.1 Conduct pre-construction conference with *OWNER*, Contractor, and other required government agencies.
- 1.3.2 Review equipment submittals, shop drawings, and other submittals from Contractor.
- 1.3.3 Prepare Change Orders for *OWNER*'s and funding agency's approval.
- 1.3.4 Provide contract documents interpretations.

- 1.3.5 Review Contractor's monthly payment requests, and forward payment requests to **OWNER.**
- 1.3.6 Make final inspection of completed improvements with *OWNER*
- 1.3.7 Advise and assist *OWNER* in initial start-up of improvements, including on-site observation, direction, and monitoring as required.
- 1.3.8 **ENGINEER** will provide a competent Resident Project Representative who will observe the work while construction is in progress. The **ENGINEER** will make on site observations during **PROJECT** construction. Such construction observation does not guarantee the work of the contractor nor provide any control over the contractor's work methods. The presence or absence of a construction observer does not relieve the contractor of sole responsibility for safety at the work site.
- 1.3.9 Testing of concrete properties by certified personnel and laboratory. Includes field testing be as well as delivery to sub-consultant's certified laboratory in Garden City KS or Hays KS, at *ENGINEER's* discretion, and sub-consultant laboratory testing fees.
- 1.3.10 Testing of soil density via nuclear density testing gauge.
- 1.3.11 Create as-built drawings to be provided to the *OWNER*.

1.4 CHANGES IN SERVICES

1.4.1 **OWNER** may request changes in the scope of the services of **ENGINEER**. Such changes shall be mutually agreed upon by and between **OWNER** and **ENGINEER**. Changes in fee associated with changes in the scope of work shall be negotiated between **OWNER** and **ENGINEER** and be incorporated in written amendments to this **CONTRACT**.

SECTION 2 -OWNER'S RESPONSIBILITIES

- 2.1 **OWNER** shall provide full information to **ENGINEER** concerning the **PROJECT** including all available plans, maps, plats, proposed construction plans, other reports and correspondence, and the **OWNER**'s recommendations. **OWNER** shall provide labor and equipment necessary to assist in locating existing lines owned by the **OWNER**.
- 2.2 **OWNER** shall examine and review the plans and specifications and inform **ENGINEER** regarding any decision thereto.
- 2.3 **OWNER** shall work diligently, with assistance from the **ENGINEER**, to collect, tabulate, and provide all information required for the design.
- 2.4 **OWNER** shall pay **ENGINEER** at monthly intervals for Engineering Services under this **CONTRACT** based on the percentage of work completed according to the following schedule:
 - 2.4.1 For services under Paragraph 1.1 & 1.2 Lump Sum \$ 80,000 (Surveying Services & Engineering Design)
 - 2.4.2 For services under Paragraph 1.3 Time & Materials NTE \$ 120,000 (Construction Engineering & Construction Observation See 2.5 below)
 - 2.4.3 For services under Paragraph 1.8 As set forth in Agreement for Changes (Changes in Service) in Service.
- 2.5 The Engineering Fee for Construction Engineering and Observation under Paragraph 1.3 shall be invoiced on a *Time and Materials* basis as in **ATTACHMENT 1**. A *Maximum Not to Exceed* cost without written authorization from the *OWNER* shall be used. Amounts in excess of the *Maximum Not to Exceed* cost, if necessary, shall be incorporated into this *CONTRACT* by amendment.

2.6 The Lump Sum includes compensation for **ENGINEER'S** services and services of **ENGINEER'S** Consultants, if any. Appropriate amounts have been incorporated in the Lump Sum to account for labor costs, overhead, profit, expenses, (other than any expressly allowed Reimbursable Expenses), and Consultant charges.

SECTION 3 - MUTUAL CONSIDERATIONS

- 3.2 **ENGINEER** covenants that **ENGINEER** has no, and shall not acquire any, interest, direct or indirect, in the **PROJECT** or any parts or parcels therein, or any other interest which would conflict in any manner or degree with the performance of Engineering Services under this **CONTRACT**. **ENGINEER** further covenants that, in performance of this **CONTRACT**, no person having any such interest shall be employed.
- 3.4 This *CONTRACT*, and all contracts entered into under the provisions of this *CONTRACT*, shall be binding upon the parties hereto and their successors and assigns.
- 3.5 The *STANDARD TERMS AND CONDITIONS*, provided hereto as **ATTACHMENT 2**, are incorporated in and form a part of this *CONTRACT*.
- 3.6 **ENGINEER** hereby agrees to comply with those portions of the following acts, orders, laws, and regulations which specifically apply to the Engineering Services performed under the **CONTRACT**:

STANDARD TERMS AND CONDITIONS EVANS, BIERLY, HUTCHISON & ASSOCIATES, P.A.

SECTION 1: Scope of Work

Evans, Bierly, Hutchison & Associates, P.A. (hereinafter referred to as **EBH**) shall perform the services defined in the contract for the stated fee arrangement. Client may request incidental or additional services not specified in the contract which change the Scope of Work and **EBH** will provide these additional services at the contract fee schedule rate; provided, that if such additional services are beyond the scope of the contract, the fee arrangement will be negotiated at the time such services are requested.

SECTION 2: Access to Site

Unless otherwise stated, **EBH** will have access to the site for activities necessary for the performance of the services. **EBH** will take reasonable precautions to minimize damages due to these activities, but has not included in the fee the cost of restoration of any resulting damage.

SECTION 3: Dispute Resolution

Claims or disputes between Client and EBH arising during design, construction, or post-construction shall be submitted to non-binding mediation. Client and EBH agree to include a similar mediation agreement with all contractors, subcontractors, sub-consultants, suppliers, and fabricators, thereby providing for mediation as the primary method for dispute resolution between all parties.

SECTION 4: Billings and Payments

Invoices for EBH's services shall be submitted, at EBH's option, either upon completion of such services or on a monthly basis. Invoices shall be payable within 30 days after the invoice date. Payment shall not be contingent upon actions or participation of any party other than Client. In the event of a disputed or contested invoice, only the portion so contested shall be withheld from payment.

Interest at a rate of 1.5% per month, or the maximum allowed by law, will be charged on past due amounts starting 60 days after the date of the invoice. Payments will first be credited to interest and then to principal. No interest will accrue on any reasonably contested portion of an invoice until mutually resolved. If Client fails to make payment in full within 60 days after the date of an undisputed invoice, EBH may, without waiving any claim or right against Client and without liability whatsoever to Client, terminate the performance of services. In the event any portion of an account remains unpaid 90 days after billing, Client shall pay all costs of collection, including reasonable attorney's fees.

SECTION 5: Ownership of Documents

All reports, plans, specifications, calculations, estimates, documents, and other work products, including all work products on electronic media, prepared by **EBH** as instruments of service shall remain the property of **EBH**. Client agrees to hold harmless, indemnify, and defend **EBH** against all damages, claims, and losses arising out of the reuse of or changes made to plans and specifications without the written authorization of **EBH**. All documents produced by **EBH** are copyrighted by Evans-Bierly-Hutchison & Associates, P.A. Documents may not be photocopied, traced, distributed or reproduced in any form or by any means, or stored in a database or retrieval system, without the expressed written permission of Evans-Bierly-Hutchison & Associates, P.A.

SECTION 6: Standard of Care

Services provided by **EBH** under the contract will be performed in a manner consistent with that degree of care and skill ordinarily exercised by members of the same profession currently practicing under similar circumstances. No other warranty, express or implied, is made or intended by the contract for services.

SECTION 7: Construction Methods and Job Site Safety

EBH will not have control over or charge of, and will not be responsible for, construction means, methods, techniques, sequences, or procedures, nor for safety precautions and programs in connection with the work.

EBH shall not be required to execute any document that would result in EBH's having to certify, guarantee, or warrant the existence of conditions whose existence EBH cannot ascertain.

SECTION 9: Termination of Services

Either Client or EBH may terminate the contract at any time with or without cause upon giving the other party 7 days prior written notice. In the event of termination, Client shall pay EBH for all services rendered and all reimbursable expenses up to the date of termination, plus reasonable termination expenses.

I. REQUEST OR ISSUE

IFB 2023-07 is our solicitation for Demolition and Removal of Structures at 1523 Colorado Ave lots 3 & 4. Our previous solicitation, IFB 2023-03, was tabled during the 5/1/2023 City Commission meeting. The meeting minutes from the 5/1/2023 meeting are as follows:

- Zach stated, staff recommends awarding bid for demolition. Does the plumbing have a hookup to sewer line as I do not see it on the GIS? Wayne stated, of course it does. Mayor Thompson stated, the bid was to demolish two trailers but only one is standing. Vice-Mayor Howard stated, the frame of one and the second trailer remain there. Wayne stated, the one trailer is sold and will be picked up in couple days. Mayor Thompson asked, you mentioned piping water over from other house? Wayne stated, it was suggested to do by the downstairs office. I have money to turn utilities on, but cannot complete process without water installed. Kent stated, that situation will create more problems and city code does not allow two properties connected to one meter. That also was not the only issue with the property. Wayne stated, one trailer is shot and the other trailer was kept up until my father passed a few years ago. There is nothing structurally wrong with my father's trailer. Mayor Thompson stated, this has been an ongoing discussion for some time. I thought in a previous discussion you were using parts from one trailer to fix other trailer. Wayne stated, that is correct. In taking down one trailer I have gained a lot of knowledge. The other trailer only has two leaks that I know how to fix. Commissioner Showalter asked, why are you selling property? Wayne stated, I wanted to see what interest I could get on the house. The gentleman I mentioned before has stepped up to help me. My yard is a mess because I have had to take stuff out of house. Commissioner Showalter stated, this has carried on for months, I wonder if you think we are serious. We have given you ample time and feel we keep getting the run around. The progress we have asked for is not there. Wayne stated, I am making progress you requested but did not bring pictures. I am tired of



it also. Commissioner Showalter stated, if we vote tonight, I will vote for demolition. It is taking up time and we need to deal with other issues. Wayne stated, I am working hard and am close to completion. Mayor Thompson stated, you still have the issue with water meter. Wayne stated, I was at a bad part in my life but I am willing to do the work myself. I have a good job now so I can get taxes paid and property improved. Mayor Thompson asked, why do you want to keep trailer so bad? Wayne stated, it is the reason I came here as that is all I have left of my dad. Mayor Thompson stated, I appreciate what you are feeling. The bid was for two trailers but now we are down to one. Kent stated, we have one and the remains of second, if it is not removed. The vendor went to visit property last week, so it has not been long ago. Zach confirmed the property is in different shape today. There were issues with both trailers on property. Either way, to consider allowing property to remain, the trailer must be habitable. A recommendation would be to allow staff to review bid to determine if adjustments should be made. Going forward, it would be difficult to have two utility bills. Wayne stated, I planned on renting the house and live in trailer. I also have considered fixing up both to rent and leave the area. Kent stated, we are trying to follow the rules. These are difficult choices but we need to be fair to the neighbors and you. We could check on current status of property and work with vendor. There was a list on both trailers that needed addressed. Vice-Mayor Howard stated, we need a strict timeline set up for improvements, if you miss one deadline, it all gets moved. This puts us in a bad spot. Kent stated, this does not mean you can remove things to neighboring properties. Wayne stated, I intended to use city wide clean up to help haul stuff away. Commissioner Showalter stated, that is not the purpose for city wide clean up. Wayne stated, I am looking at a refrigerator, washer and dryer. I want to take responsibility for what I need to do. This is my last attempt. I want it gone. Commissioner Redlin stated, we need clarification of bid adjustments and I question how the trailer is livable. Is sewer really hooked up? If we do not see movement by next meeting and a plan in place we need to move forward with demolition with adjusted bid. Mayor Thompson stated, I agree with Kent and Commissioner Redlin. Jake stated, if you want to table the bid that is what needs to happen. If you want to award the bid, you need to call for the vote.

A bid opening for IFB 2023-07 was held 6/2/2023 at 11:00 A.M. One bid was received from Brian Rippe-B&K Pumping for a total bid of \$4850 . I recommend award to the Brian Rippe.

Below are statements to help you decide if you are an independent contractor. No one statement is controlling, and your status is based on all the facts in your situation.

- 1. The nature of the contract between you and the contractor shows you are independent from the contractor. For example: Is there a written contract where you agree that you are an independent contractor? Do you maintain commercial general liability insurance or other business insurance?
- 2. The contractor exercises very little control over the details of your work or independence. You exercise control over most of the details of the work? Do you create plans or specifications for the job? Do you set your own work hours?
- 3. You are engaged in a distinct occupation or business for others. Do you work for companies or individuals other than the Contractor? Do you work for competitors of the Contractor? Does your business have a logo or uniform?
- 4. Your job is the kind of occupation where the work is usually performed by a specialist without supervision, and not under the direction of the contractor.
- 5. Your occupation requires special skills, license, education or training.
- 6. The contractor does not supply the things needed to perform your job such as the tools and the place of work. Do you operate a vehicle owned by the contractor? Was the work performed at your business or the contractor's business location or jobsite?

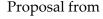

Exhibit B - Terms and Conditions

A. GENERAL TERMS AND CONDITIONS

The Terms and Conditions (the "Terms") of this Proposal govern the sale of services (the "Services") by Utility Service Co., Inc. (which for purposes herein shall include its affiliates) to the Customer. All other terms, or variations to these Terms are excluded unless agreed explicitly in writing by a numbered amendment to this Proposal executed by Utility Service Co., Inc. and the Customer. These Terms shall supersede all prior terms, understandings or Proposals between the Customer and Utility Service Co., Inc. If any part of the Terms should be found to be invalid or unenforceable by a court or other competent authority, then the remainder of the Terms shall not be affected. Any notice to be given with respect to these Terms by either of the Parties shall be in writing. This Proposal has been issued based on the information provided by the Customer and on information currently available to Utility Service Co., Inc. at the time of Proposal issuance. Any changes or discrepancies in site conditions, concealed conditions where the Services will be performed, changes in environmental, health, and safety regulations or conditions, changes in Customer's financial standing, Customer's requirements, or any other relevant change or discrepancy in the factual basis upon which this Proposal was created may lead to changes in the offering, including but not limited to, changes in pricing, warranties, quoted scope of work, and/or terms and conditions. Unless stated otherwise in the Proposal, performance and/or payment bonds are not included in the price. These bonds can be purchased on request but will be at an additional cost.

B. PRICES, PAYMENT TERMS, COMMITMENT OF CUSTOMER, CREDIT REPORTING AND TAXES

Prices, which are expressed in US Dollars, are only valid for the period stated in the Proposal. If not stated, the validity period is ninety (90) days. Unless otherwise stated in the Proposal, the full price shall be due and payable upon completion of the Services, which may or may not include the installation of Equipment. All of Utility Service Co., Inc.'s invoices are due and payable upon receipt. If any payment is not made by the Customer within sixty (60) calendar days following the date of the invoice, Utility Service Co., Inc. reserves the right to charge a late payment charge of one and one-half percent (1.5%) per month of the outstanding past due balance. Any failure by Customer to make timely payment of any obligation under this Proposal shall be deemed a breach. Customer agrees to reimburse Utility Service Co., Inc. for all charges, costs, expenses and attorney's fees incurred to enforce or collect the amounts due under this Proposal. In the event Customer has a valid dispute with any invoice or amount due, such dispute must be communicated in writing to Utility Service Co., Inc. within thirty (30) days of the invoice date, describing the amount, issue and the reason for any dispute. Any amounts not disputed within this time frame will be deemed to be valid. Utility Service Co., Inc. and Customer agree to work expeditiously to resolve any dispute. By executing this Proposal, Customer authorizes Utility Service Co., Inc. to periodically request your credit reports and bank and trade references. Upon your request, we will inform you of the name and address of the reporting agency from which we received such a report, if any. The price listed in the Proposal excludes all taxes unless specifically stated otherwise in the Proposal. The Customer is responsible for payment of all applicable taxes, however designated or incurred in connection with the transactions under this Proposal, and agrees to reimburse Utility Service Co., Inc. for any taxes paid on

C. DELIVERY OF SERVICES AND INSTALLATION OF EQUIPMENT

The provision of Services as contemplated herein might require the installation of certain equipment (the "Equipment") on the Customer's real property or on the improvements to the Customer's real property (e.g., water storage tank, etc.). All times and dates for the delivery of Services and/or installation of Equipment are approximate, but Utility Service Co., Inc. shall use its reasonable efforts to respect them. H. NOTIFICATION OF WARRANTY CLAIM

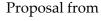

K. SATISFACTION OF WARRANTY CLAIM

If Utility Service Co., Inc. verifies, in good faith, that a claim under the Warranty is valid and not subject to an exclusion pursuant to Section I above, Utility Service Co., Inc. agrees to repair or replace, without expense to the Customer, any workmanship, materials, and/or Equipment, if applicable, furnished hereunder that may prove defective within the Warranty Period. The Warranty provided in this Proposal shall be the sole and exclusive remedy of the Customer.

L. INDEMNIFICATION

Utility Service Co., Inc. shall indemnify and hold harmless Customer from all claims for physical damage to third party property or injury to persons, including death, to the extent caused by the negligence of Utility Service Co., Inc. or its officers, agents, employees, and/or assigns while engaged in activities under this Proposal. M. FORCE MAJEURE

Utility Service Co., Inc. shall not be liable to the Customer for non-performance or delay in performance of any of its obligations under this Proposal due to: (i) acts of God (which include, but are not limited to, tropical storms, hurricanes, tornadoes, and earthquakes), (ii) failure of the Internet or another network, (iii) war, (iv) riot, (v) civil commotion, (vi) embargo, (vii) labor disputes, (viii) labor strikes, (ix) fire, (x) flood, (xi) theft, (xii) epidemic, (xiii) pandemic (including COVID-19), (xiv) delay in delivery of services, materials, or equipment by subcontractors, suppliers, or manufacturers, (xv) shortage of labor or materials, or (xvi) any other unforeseen event (whether or not similar in nature to those specified) outside the reasonable control of Utility Service Co., Inc.

N. LIMITATION OF LIABILITY

Management level representatives of both Parties shall meet at an agreed location and attempt to resolve the dispute in good faith. Should the dispute not be resolved within sixty (60) days after such notice, the complaining Party shall seek remedies exclusively through arbitration. The seat of arbitration shall be the federal district court closest to the location where the Services were performed or are scheduled to be performed, and the rules of arbitration will be the Commercial Arbitration Rules of American Arbitration Association, which are incorporated herein by reference into this Section O.
